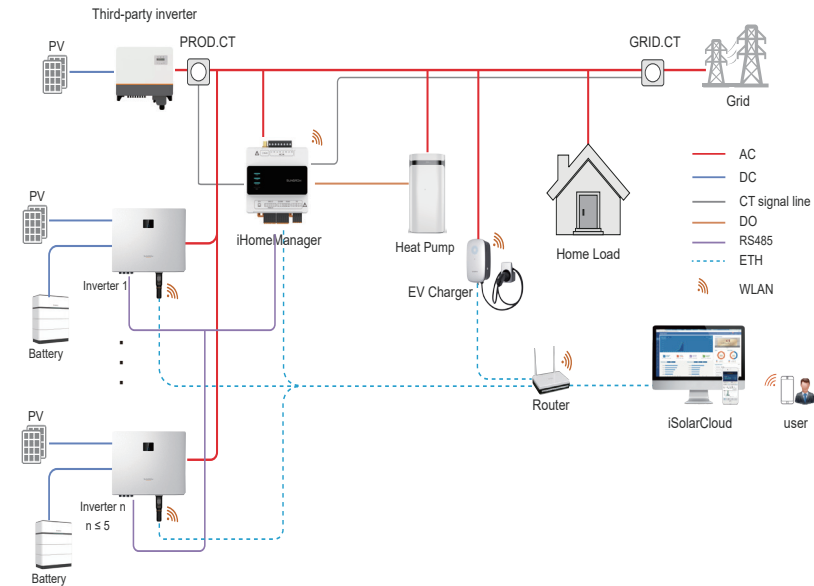
1.2 Residential PV-ESS-EV charging system (RS485)



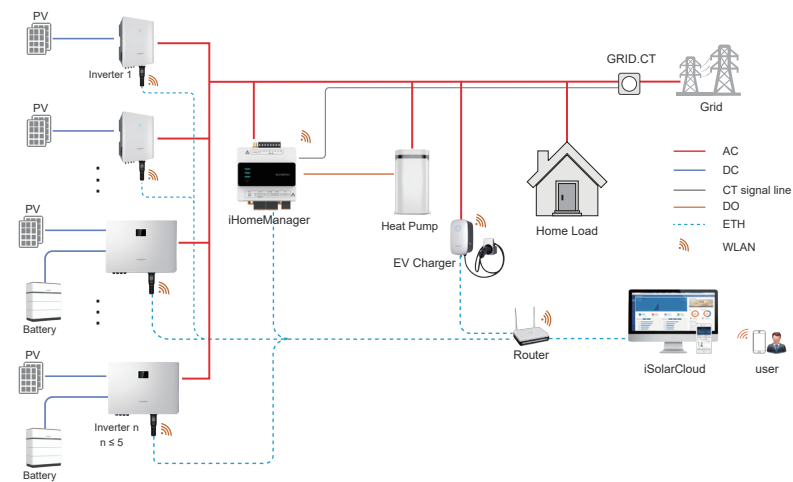
